Gym Membership Terms and Conditions

General

1. The purchase of a gym membership, of any category, indicates your acceptance of these terms and conditions.
2. Your gym membership will commence on 3rd January 2020, or if purchased on or after this date on the date of your purchase, and will expire after the relevant period has elapsed.
3. When your membership commences, this agreement becomes binding on you and The Leisure Box. A contract will be formed between you and The Leisure Box.
4. You cancel this contract at any time, by contacting us on 01282 222380 or leisurebox@burnleyfc.com.
5. This agreement is non transferrable.
6. Members must be a minimum age of 16.
7. You agree to comply with the gym rules, which are displayed in the gym.
8. The rules of this agreement will be enforced at our discretion. If we do not take action for one misdemeanour, this may not prevent us enforcing this agreement at a future point.
9. We will not be liable for any failure to honour this contract as a result of an event that is outside of our reasonable control.
10. This agreement is subject to English Law.
11. If you are found to be in breach of any of these terms on conditions or Gym Rules, we may terminate this agreement, along with your membership, with immediate effect.
12. You will notify us immediately should your health status change. You may be advised to consult a medical professional prior to continuing to exercise. Failure to notify the Leisure Box of a change in your health status may result in your membership being suspended or terminated.

Membership Fees and Payment

1. A payment for any membership is due on purchase. Payment on purchase is as follows:
 - a. Rolling Monthly Membership – 1 month membership.
2. Rolling Monthly Memberships are paid in advance of the month ahead.
3. All Monthly Rolling Membership payments will be taken on the date of the month which corresponds with the date of joining, or the nearest working day.
4. Each payment received by The Leisure Box is not refundable.
5. If a payment is missed, your membership will be cancelled, and you will be required to resubscribe and pay the price current at the time.

6. Monthly Rolling Memberships can be terminated at any point by cancelling the payment with your bank. Your membership will expire at 11.59pm on the day before you next payment is due.
7. Rolling Monthly memberships will expire at the end of the term i.e. after 1 month. No refund will be given should you cancel your membership, or cease to use the facility prior to the end of the term.
8. Should it be necessary to increase prices, we will give you a minimum of 30 days notice. Your right to terminate your membership during this time is unaffected.
9. The free iPRO GYM welcome pack (worth over £10) is currently in production and will be distributed to the first 300 members as soon as the products arrive.

Health and Safety

1. Prior to using any fitness equipment new members will be given the opportunity to book a supervised induction with a member of the Leisure Box team; these inductions should be booked in advance. Equipment and facilities must be used in a safe manner at all times, in accordance with training or guidance given by a qualified member of staff or relevant signage. No equipment should be used if you are unsure how to use it. Facilities' users are responsible for their own health and safety and should conduct their activities in a safe manner at all times so as to not impact on the health and safety of themselves or others when on the premises.
2. You should consult your doctor before you start any exercise regime and/or if you are not sure whether it is suitable and/or if you have a pre-existing illness or medical condition.
3. We accept no liability for lost or stolen goods whilst on our premises. Property stored in lockers is at your own risk. Cars parked in the car park and all contents in them are your responsibility and we will not accept liability for loss or damage to them.

Access

1. The gym will be open as follows:
 - a. Monday – Friday: 7am-10pm
 - b. Weekends & Bank Holidays: 8am-8pm
2. The Leisure Box reserves the right to change these opening times with 14 days notice.
3. Last entry to the gym will be 45mins prior to closing.
4. The gym can be accessed via the main entrance to the Leisure Box. Members can either use the lift to the main floor or the main staircase. There are then 42 steps down to the gym. Alternatively there is an accessible route using the main entrance, and lift to Floor 0, and following the walkway around the exterior of building to the lower entrance.
5. The Leisure Box will ensure that the I-Pro Gym is staffed at peak times. At other times, whilst there will always be staff within the Leisure Box, there may not be a dedicated gym instructor in the gym. For your safety, the gym area is monitored by CCTV recording equipment at all times
6. The building must be vacated by the published closing time i.e. if you are going to shower and change, please allow sufficient time to do this.

7. There may be times when we need to partially or fully close the gym. We will do our best to ensure that any closure is outside of peak times, and give advance notice. However, on occasion unforeseen events may mean that this is not possible. In this situation, you will not be entitled to any refund.
8. Your access PIN/Card is for your personal use only. Any member believed to be, or found to be allowing another person to use their access details and/or allowing 'tailgating' will have their membership terminated immediately.
9. If it is found that you have allowed another person to use your access details, or allowed them access to the gym with you, we will hold you solely responsible for their conduct whilst on our premises, and also for any damage or loss (financial or otherwise) that The Leisure Box suffers as a consequence. Your membership will also be cancelled immediately with no subsequent opportunity to re-join at a later date.

How we use your personal information

We will use the personal information provided to us to:

1. Provide the services associated with your membership.
2. Process your payment for such services; and
3. If you have consented to receive such emails we will inform you about other products or services that we provide. These communications will only be shared with those members who consent to receiving this communication at the point of sign up. You are able to opt in or out of these communications at any time by contacting us.
4. Any personal data we collect from you will only be used by us in accordance with Data Protection Legislation in force. The processing and storage of this data is detailed in our privacy policy which can be accessed on our website at www.theleisurebox.org/privacypolicy.
